# Annual Membership Meeting

The Annual Membership Meeting was held Thursday, May 16, 2024 at the Carousel Shelter, Alameda Park. There were 42 members in attendance. Board, Supervisory Committee, and Credit Committee members present were introduced, along with current staff members. Reports were provided on Credit Union Audits, Milestones, Membership Accounts, Loans, Income, Dividends, Expenses, and Policies/Procedures. Seven membership surveys were returned and the following comments were received. What services that are currently offered do you find most useful? Comments: accounts for grandchildren, introduction of share certificates, and ability to speak to a person for loan/account information. What additional services would you like to see the Credit Union Provide? Comments: Online access to accounts, online banking may eliminate the need for quarterly mailing of statements and attract younger members, ability to complete and submit loan applications online, and provide services that gives the Credit Union the ability to stay competitive within the financial markets of today. Additional comments/questions: Comments: the food was very good, keep venue/time, thanks for the meal, and love the spring meeting instead of the winter date.

#### What's New

Just a reminder of recent changes that were made:

<u>NEW OFFICE HOURS:</u> Beginning June 3, 2024, the Butler County Teachers Federal Credit Union adjusted to permanent office hours. The Credit Union will now be open MONDAY-FRIDAY from 11:00 a.m. thru 5:00 p.m.

**DEPOSIT LIMITS:** Following in-depth discussion and review with auditors, the Board of Directors has LIFTED DEPOSIT LIMITS for your Share and Christmas Club accounts. Beginning April 1, 2024, members can make deposits to their share and Christmas Club accounts in whatever amounts they choose.

**POLICY CHANGE-FUNDS AVAILABILITY:** Beginning April 1, 2024, members wishing to withdrawal \$50,000 or more may be required to provide a two-day notice prior to removing the funds.

**POLICY CHANGE-RATE FLOOR:** In the Loan Policy, there is a section that addresses Interest Rate Match and/or Bust. The rate floor has been changed to 3.0 percent. Policy language will now read: Members, based on the type of loan and pending BCTFCU credit approval, presenting written documentation of a verifiable loan approval from another financial institution or dealership, with an interest rate lower than BCTFCU's loan rate on a similar loan at the time of approval, may receive that lower rate minus an additional .25% with a rate floor of 3.00% when subtracting the additional discount.

### Frequently Asked Questions & Answers

If I have retired, do I need to leave membership with the Credit Union? NO – Once you have become a member with the Butler County Teachers Federal Credit Union, you are a member for life. As a matter of fact, should you decide to leave membership at any given time, you are <u>ALWAYS WELCOME</u> to return to membership and begin receiving full membership benefits immediately.

Who can join the Credit Union? "Initial" membership must be because of an employee from one of the Field-Of-Membership Schools. HOWEVER, once that individual becomes an employee of one of the Field-Of-Membership Schools, ANY IMMEDIATE member of his/her family can also join. Those memberships are also for life and can then be extended to those individuals' immediate family. For example, an individual from one of the Field-Of-Membership Schools joins (or is employed by a FOM school), then his/her spouse/parent(s)/ grandparent(s)/ sibling(s)/child(ren)/step-child(ren)/grandchild(ren) can also become a member. Once that individual would join, then that individual can extend membership to "immediate" family members as outlined above whether any of those individuals work for one of the Field-Of-Membership Schools or not. Therefore, a grandchild that would have an account opened during their childhood years can feasibly extend membership to his/her spouse and immediate family once the grandchild grew up regardless of whether any of those individuals work for a FOM School. This is why we believe membership is truly a gift that can be shared with family members for many generations.

Once I retire, how do I put money into the Credit Union? Once you retire, you can write a check monthly (or however often you choose) to be placed in shares. You can also go into your online Bill Payment Center of the financial institution that you use and set us up as if you were paying a bill. You will need to add Butler County Teachers FCU, 112 Campus Lane, Butler, PA 16001 to your contacts. You can also make your monthly loan payments in this manner as well. You can set up monthly, weekly, or bi-weekly payments or go in each month to your Bill Payment Center to make individual deposits and/or payments. The "memo" portion of the financial institution's records should include the member's account number and indicate whether the money is for deposit to shares/Christmas Club/Share Certificate or payment on a loan.
